RESOLUTION TO AUTHORIZE DICKSON COUNTY TO APPLY FOR AND ACCEPT A \$19,481.46 GRANT THROUGH THE TENNESSEE DEPARTMENT OF SAFETY & HOMELAND SECURITY TO BE USED TO EXPAND AND ENHANCE THE COUNTY’S EMERGENCY RESPONSE CAPABILITIES

This Resolution is to authorize Dickson County to apply and accept a Nineteen Thousand Four Hundred Eighty One Dollar and Forty Six cents (\$19,481.46) Grant through the Tennessee Department of Safety & Homeland Security to be used to expand and enhance the County’s Emergency Response capabilities. This Grant is a **100%** Grant which the County of Dickson, Tennessee will not be required to contribute any amount with the initial payments being made by the County, but then being reimbursed **100%** by Homeland Security. Motion by Commissioner Becky Spicer, second by Commissioner Cindi Gray to authorize Dickson County to apply and accept a \$19,481.46 Grant through the Tennessee Department of Safety and Homeland Security to expand and enhance the County’s Emergency Response capabilities passed by a unanimous aye voice vote.

RESOLUTION TO AUTHORIZE DICKSON COUNTY TO APPLY FOR AND ACCEPT A \$31,500.00 GRANT THROUGH THE TENNESSEE DEPARTMENT OF COMMERCE AND INSURANCE TO BE USED TO EXPAND AND ENHANCE THE COUNTY’S EMERGENCY RESPONSE CAPABILITIES

This Resolution is to authorize Dickson County to apply and accept a Thirty One Thousand Five Hundred Dollar (\$31,500.00) Grant through the Tennessee Department of Commerce and Insurance to be used to expand and enhance the County’s Emergency Response capabilities. This Grant is a **100%** Grant which the County of Dickson, Tennessee will not be required to contribute any amount with initial payments being made by the County, but then being reimbursed **100%** by the State Fire Marshall’s Office. Motion by Commissioner Danny Williams, second by Commissioner Becky Spicer to authorize Dickson County to apply and accept a \$31,500.00 through the Department of Commerce and Insurance to be used to expand and enhance the County’s Emergency Response capabilities passed by a unanimous aye voice vote.
